Brand names and trademarks of businesses may be registered with the Patent Office of the U.S. Department of Commerce. A search of the U.S. Trademark records is advised in order to determine if a proposed business name is available.

Middleton Library at Louisiana State University, the only Patent and Trademark Resource Center Library in Louisiana, has databases which are available to the public for patent searches. They also offer patent and trademark consultations.
